Broker Participation Policy

3. Broker must show the property to registered buyer and review the entire Bidders Packet with registered buyer prior to submitting a bid/offer/contract.
4. Broker's registered buyer must be the higher bidder with a binding Purchase Contract for the property.
5. Broker must assist in any reasonable request toward execution of the Purchase Contract by Broker's registered buyer.
6. The Broker's registered buyer must close the transaction in full terms under the Purchase Contract.

Provided all of the above conditions are met in full, the undersigned Broker will earn a commission equal to 2% of the final purchase price. No other commissions or fees will be paid to the participating Broker unless specifically agreed to in writing by Heritage Auctions.
